Terms & conditions:

The amount shall be paid as one time scholarship to the student(s) who meet the following criteria mentioned against the respective scholarships :

1)-Thapar Institute of Engineering & Technology Class of 1965 Scholarship

- a) The student should be a BE third year student of either Civil, Mechanical or Electrical Engineering discipline and should have had no E or F or X grade up to the first semester of the third year of his/her study.
- b) The candidate applying for the scholarship shall have to submit a research / design project proposal of his/her area of interest. The merit of project shall be judged by a committee which shall include the concerned head(s) of the Department and an alumni representative.
- c) The scholarship shall be decided on the basis of AGPA (minimum 8.00) earned during the second year of his/her study and the merit of the project proposal, from amongst the candidates who apply for this scholarship.

2)-Thapar Institute of Engineering & Technology Class of 1987 Scholarship

- a) The student should be a final year student of any under-graduate engineering discipline and should have had no E or F or X grade up to the first semester of fourth year of his/her study.
- b) The first scholarship shall be given to a student who has performed exceptionally well in any of sports during the first three years of his/her stay on TIET campus.
- c) The second scholarship shall be given to a student who has performed exceptionally well in any of the extra-curricular activities during the first three years of his stay on TIET campus.
- d) The candidate applying for scholarship shall have a minimum CGPA of 7.50 attained during the first three years of study at TIET.
