NOTE :

1. Merit–Cum-Means (Normal) scholarship is applicable for both UG and PG students whereas Merit-Cum-Means (Special) cases will be considered for UG Students only.
2. In Merit-Cum-Means (Special) Scholarship only those cases of deserving UG students will be considered which are not covered under TIET Merit-Cum-Means (Normal) and have some specific reasons. PG students will not be considered for Merit-Cum-Means (Special) scholarship.
3. Scholarships shall be awarded to the students whose parent’s gross income does not exceeds Rs. 10.00 lakhs per annum.

4. Student applying for 2nd year and onwards should have ≥ 7.00 CGPA with no backlog at the time of applying of scholarship.
5. Scholarships shall be awarded for one academic year only. Student has to apply for the Merit-Cum-Means Scholarship on the prescribed format each year after display of notice.
6. In case of a tie in family income, Girl students coming from families having no male child will be given preference.
7. The information provided by the applicant for availing the merit-cum-means scholarship can be verified by the committee at any point of time. If any information found false, scholarship will be withdrawn and disciplinary action will be taken against the student.
8. The right of awarding the Merit-Cum-Means (Normal) / Merit-Cum-Means (Special) Scholarship to the student(s) shall lie with the Award Committee.

1. 1st Year Student : JEE(main) Rank Score Card / 10+2 Mark Sheet (DMC) / Merit No. for ME / MTech /MSc.
2. 2nd onwards Students : Grade Card (CGPA) of last examination passed.

In case parents filing income tax return then self-attested copies of latest three year Income Tax returns.

4. An affidavit (duly attested by Notary) from applicant's parents declaring their total Annual Family Income from all sources and details of movable & immovable property in the format of **DECLARATION OF FAMILY INCOME & IMMOVABLE PROPERTY** given on website .
5. For availing only girl child benefit, parents are required to submit an affidavit for having girl child only duly verified by the notary.
6. A copy of Fee Receipt for current semester.
7. All relevant documents pertaining to reason for special scholarship.
8. Copy of all relevant documents relating to specific reason for applying Merit-Cum-Means (Special) Scholarship.
9. Copy of first page of student bank account pass book / crossed cheque having student name mentioned on the cheque / online bank statement having full details.
