## SUMMER SEMESTER

It is intimated to all concerned that as per the provision given in the Academic Regulations of the Institute, the summer semester has been scheduled **w.e.f. 09.06.2025**.

All students of UG/PG/Ph.D programmes (including students who have already completed normal duration) who want to clear their backlog course/s or improvement in CGPA, are eligible to apply. **Maximum three subjects shall be given in this summer semester provided there is no time-table clash.**

For improvement of CGPA, following shall be the eligibility criteria :-

1. Only those courses shall be offered to students where student has got B/B-/C/C- grade.
2. Courses for improvement can only be opted from the courses offered to the students in the summer semester i.e. no subject shall be offered exclusively for improvement.
3. **The students who have graduated in the past five years** and want to improve their CGPA can do so. They will have to take prior approval by sending an email in the name of the Director, TIET at [ss\\_a@thapar.edu](mailto:ss_a@thapar.edu). Also, they will have to surrender their original degree.
4. DOAA is authorized to decide number of subjects to be given to a particular student.
5. The students cannot opt for summer semester if there is any clash of dates with some training or project semester.
6. **No course from the current semester (i.e. Even Sem of session 2024-25) will be offered to any student in summer semester with the exception of UG and PG-Final year students.**

The fee to be charged for attending summer semester (for all cases i.e. new course or backlog course or improvement course) is *Rs. 15,000/- per course* (mode of payment given at the end):-

Duly filled application form (available with this Notice) **along with proof of fee payment** should be submitted in Academic Section **by following dates:**

**Last date without late fee : May 16, 2025 (5:00 pm)**

**Last date with a late fee of Rs. 1000/- per course: May 20, 2025 (5:00 pm)**

Further, in the summer semester, regular classes will be held if number of students in a course is 6 or more. If the number of students is less than 6, the course(s) will be offered as a self- study to students having 'E'/'I' Grade/s. An instructor will, however, be appointed and all the components of evaluation will be completed. No course will be offered as self-study course to the students having 'F' or 'X' Grade.

*Please note that course(s) in Summer Semester will be offered subject to availability of faculty.*
